

Information on the processing of personal data

The purpose of this document is to provide the information on the processing of your personal data to the company TSR Slovakia s.r.o., based Röntgenova 28 851 01 Bratislava within the meaning of Article 13 et seq. of the European Parliament Regulation and Council No. 2016/679 on the protection of individuals in connection with the processing of personal data and on the free movement of such data and on repealing the Directive 95/46/EC (hereinafter referred to as "GDPR"). We approach your personal data carefully and try to minimize all processing that takes place.

Personal data and their processing in connection with the fulfilment of legal obligations in waste collection, purchase, and processing

For waste collection, purchase, and processing, we process your personal data in the scope of **name, surname, address of permanent residence, and identity card number**, for the purpose of fulfilling **obligations** according to Article 18 of Waste Act No. 541/2020 Coll.

For purchasing the types of metal waste listed below, we process your personal data in the scope of **name, surname, address of permanent residence, and number of identity card or other identity document** for the purpose of fulfilling **record-keeping obligations** according to Article 18 of Waste Act and in connection with Section 8 of Decree no. 383/2001 Coll., on details of the treatment of waste products.

TSR Slovakia s.r.o. as the operator of the collection or purchase facilities the above waste is obliged when collecting or purchasing these wastes **to identify persons**, which it intends to collect or purchase waste, **to identify collected or purchased wastes** and **keep records of these facts**. The company is empowered **to require identity cards of these persons for inspection** and record legally required data (see above) from these cards for that purpose.

The operator of the collection or purchase facility may provide you with a **cashless payment** for the said waste only. We process **your bank account number** for that purpose.

Additional information to holders of personal data

We will store your personal data in electronic form for 5 years as required by the Waste Act. After the expiration of the archiving period, personal data will be securely and irreversibly destroyed so that they cannot be misused.

Upon request, we share your data with government agencies that are authorized to control our activities (trade licensing offices, tax offices, regional offices, municipalities with extended powers, Slovak Environmental Inspectorate, Police of the Slovakian Republic) and possibly with other entities, if it is necessary for the protection of the rights of TSR Slovakia s.r.o.

We do not transfer your personal data to other branch offices of TSR Slovakia s.r.o. or to any other persons in other countries.

At TSR Slovakia s.r.o., the personal data provided by you are protected against leakage and misuse by the organizational and technical measures referred to in internal directive for the processing of personal data. All persons who come into contact with personal data in the context of the performance of their work or contractual obligations are bound by a legal or contractual obligation of confidentiality. If personal data were transferred to other entities (including transfer abroad), TSR Slovakia s.r.o. would conclude relevant contracts with data processors, through which these entities guarantee compliance with obligations relating to the processing of personal data under Slovakian law.

Video and audio recording and their processing

As a rule, we monitor the establishment area at operating a facility for taking over your waste continuously (see the camera symbol, other information respectively on recording by the camera system installed at the establishment) using a camera system; we record your video or audio records while doing so for the purpose of protection of property and persons, who are present in the establishment. This obligation follows from the Waste Act No. 541/2020 Coll. The record will be kept for 30 days. It will be deleted after this time in accordance with the internal rules on the handling of personal data.

Your rights

If you reside in the territory of the European Union, you have the right based on GDPR to request from TSR Slovakia s.r.o. an access to your personal data, their correction or deletion, their transfer, limitation of their processing, then you have the right to object to the processing of your personal data, and the right to lodge a complaint with the supervisory authority (Office for Personal Data Protection - <https://dataprotection.gov.sk/uouu/>).
